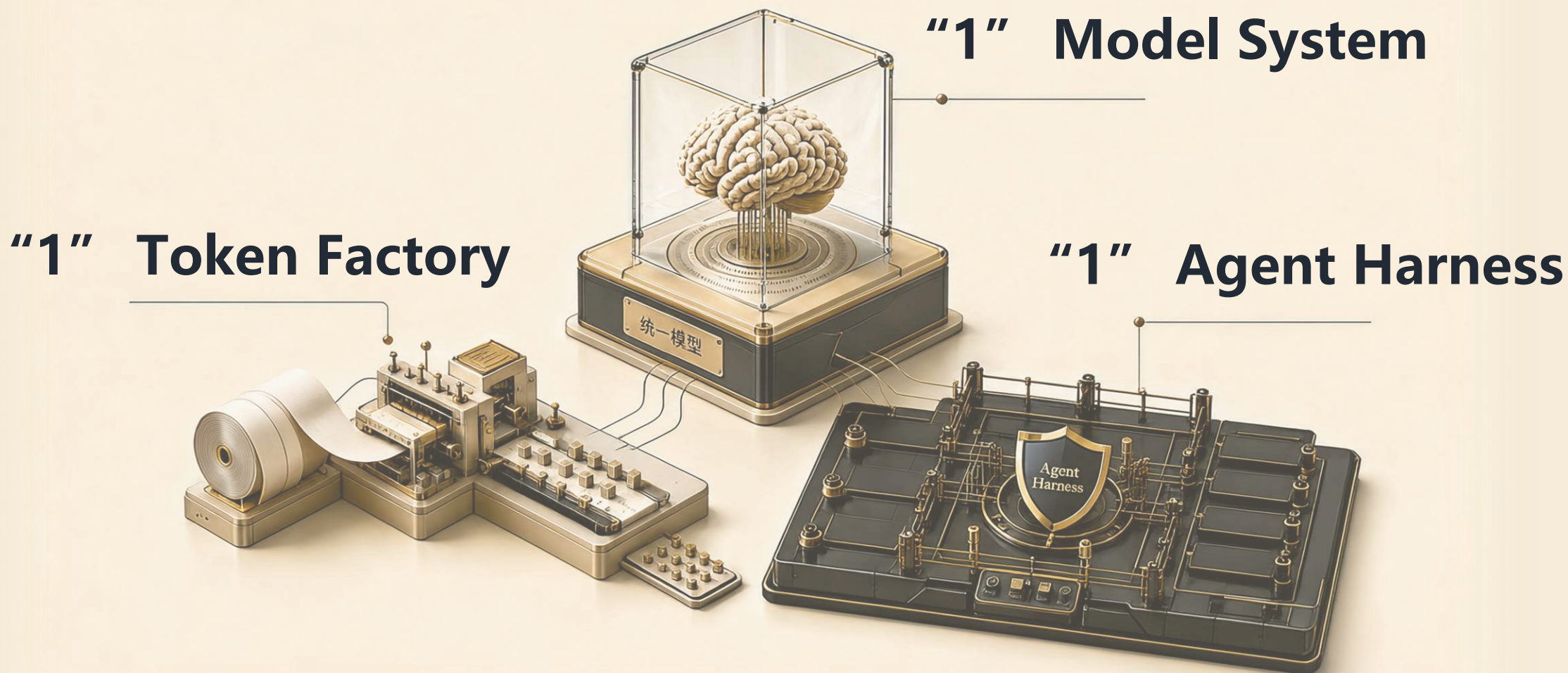

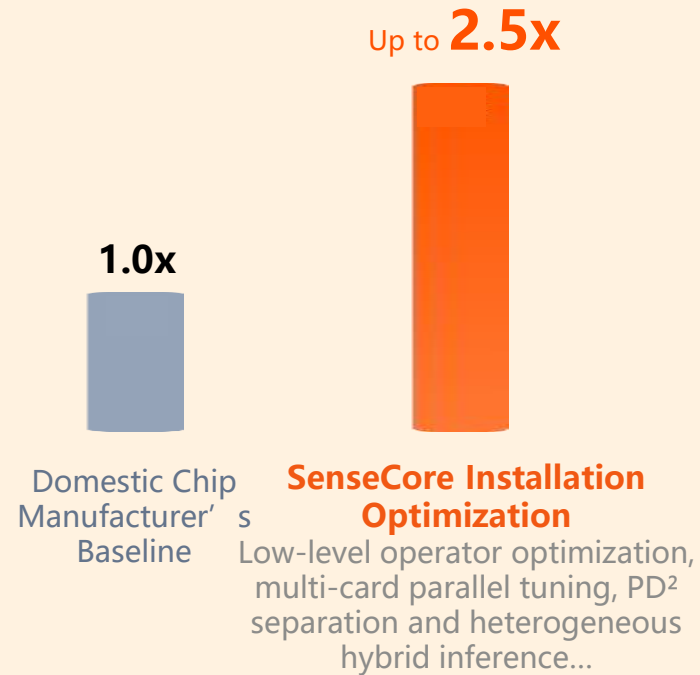

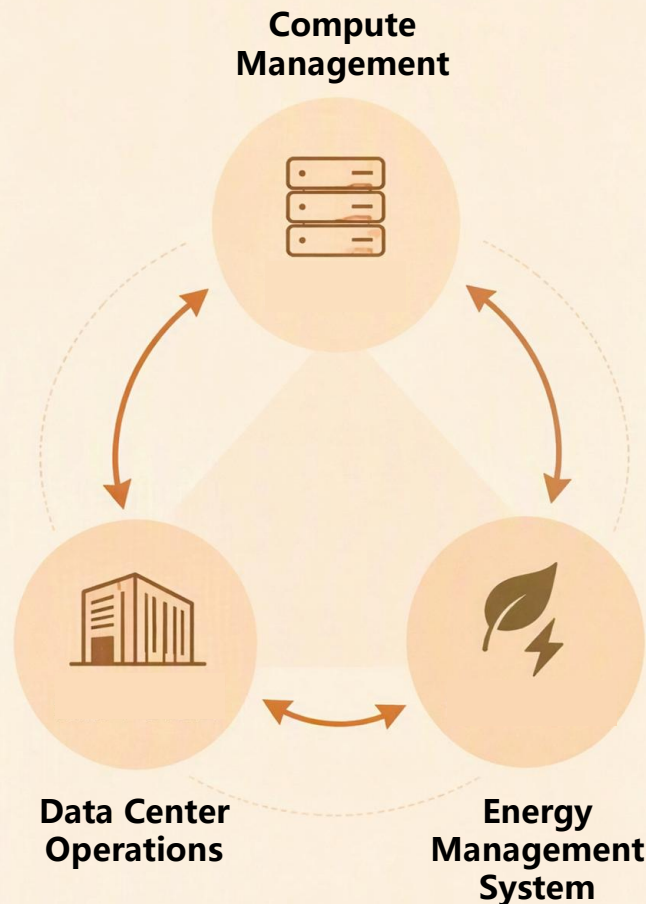

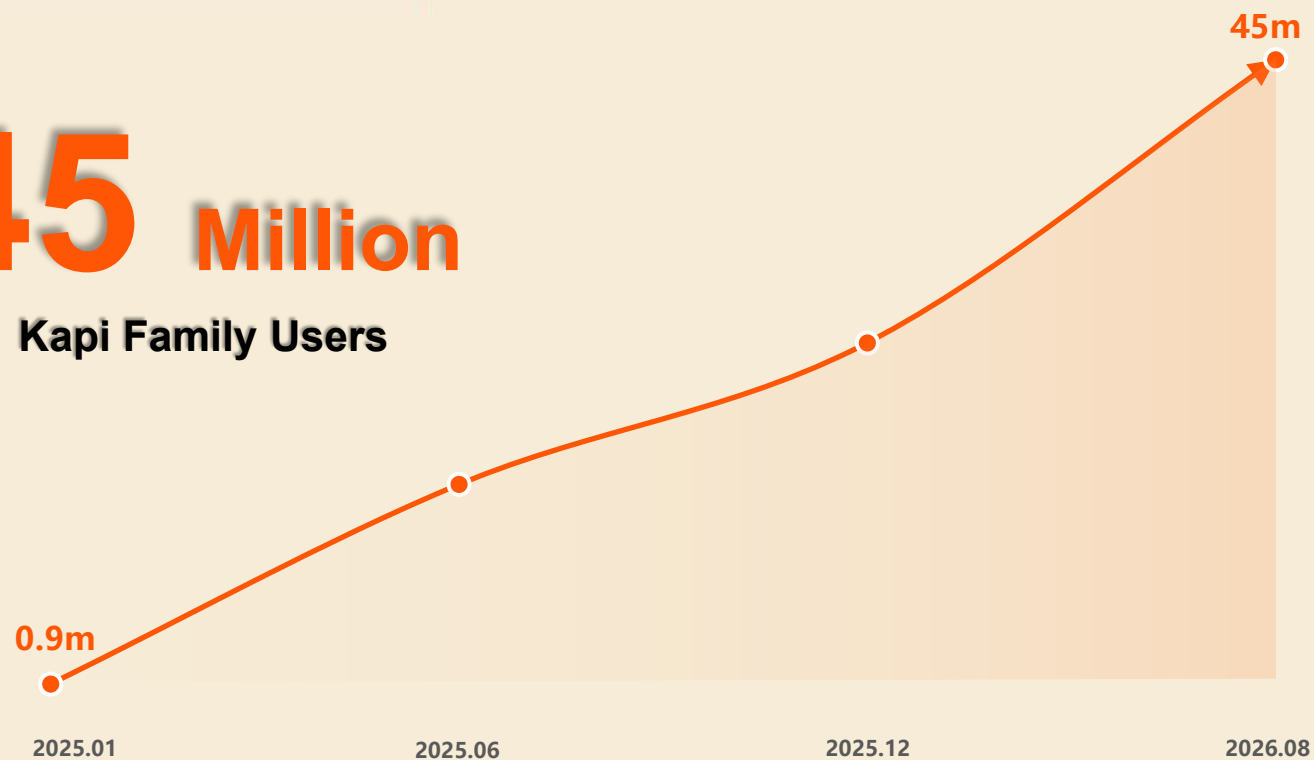

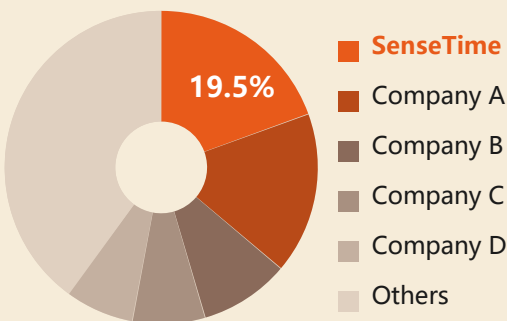

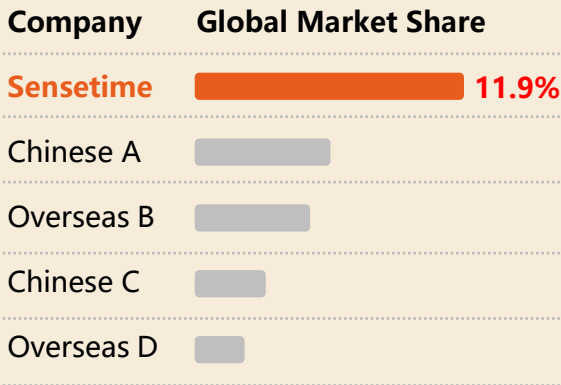

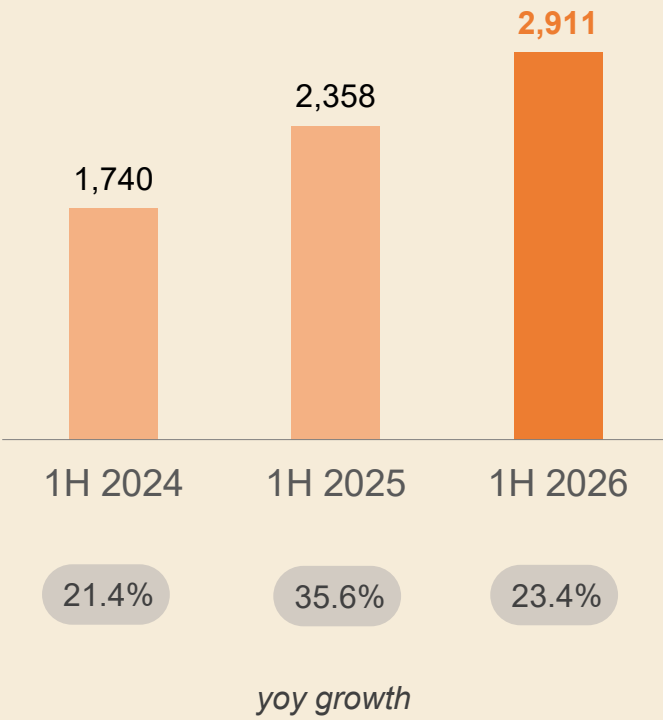

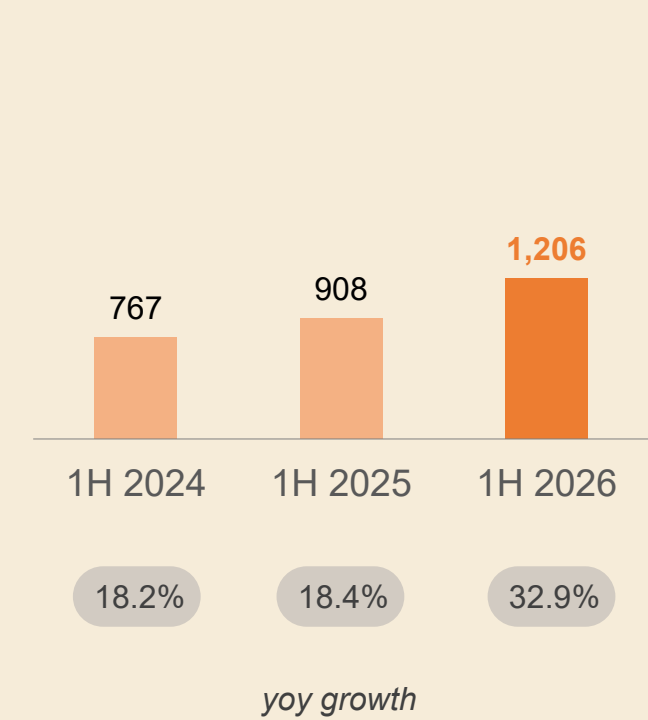

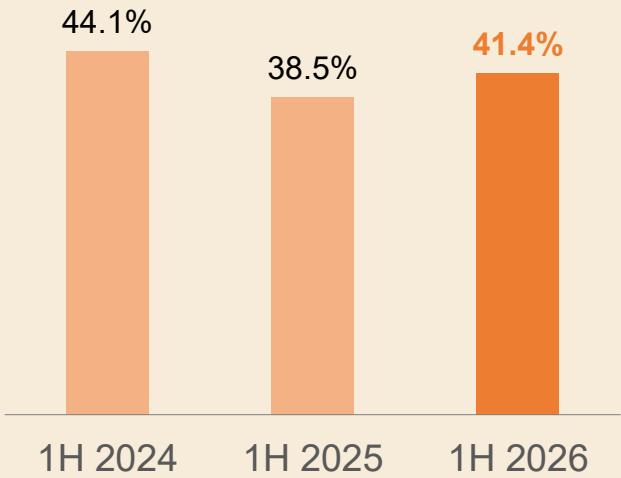

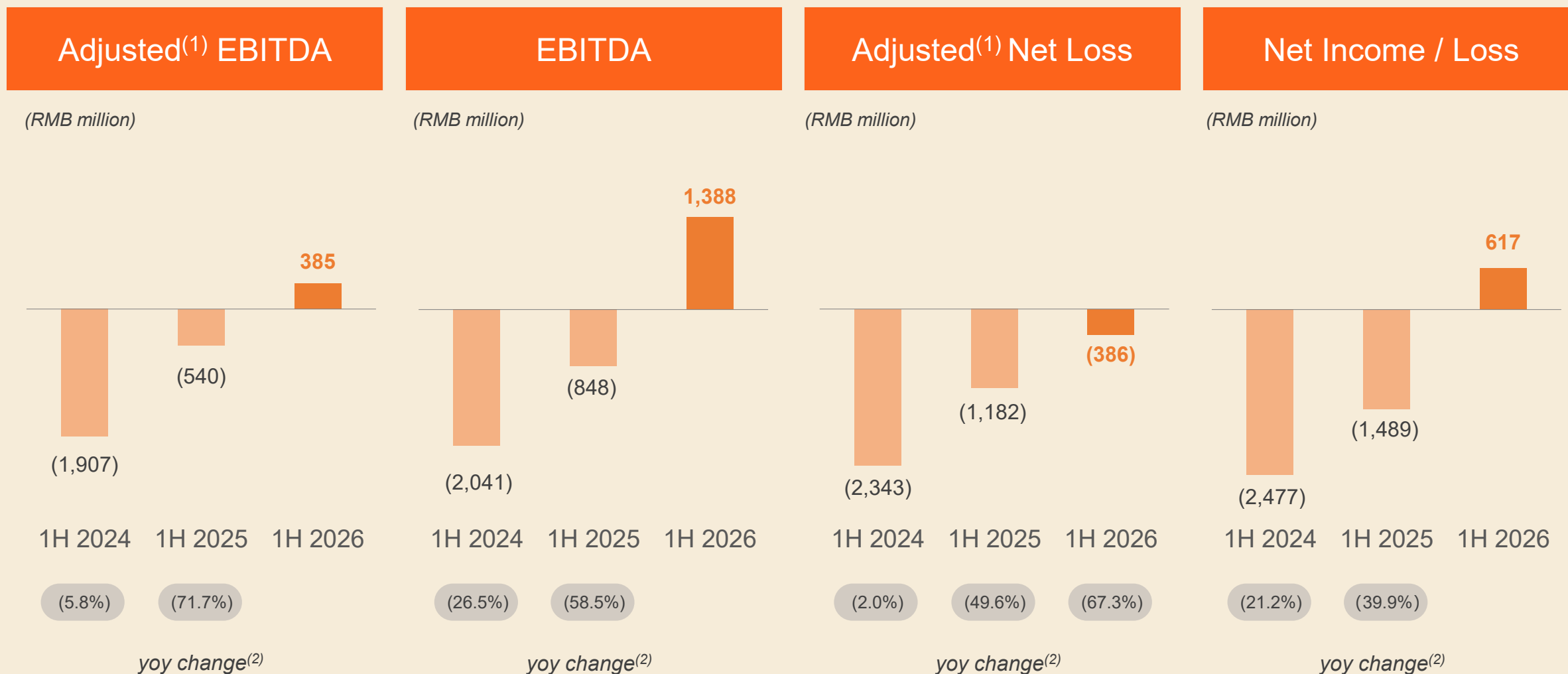

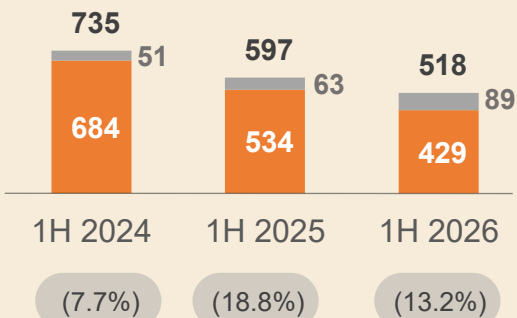

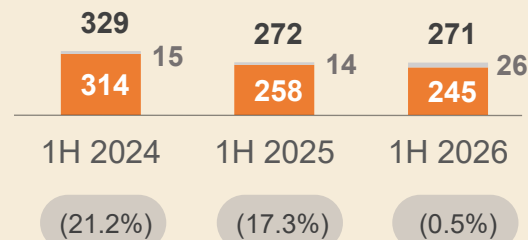

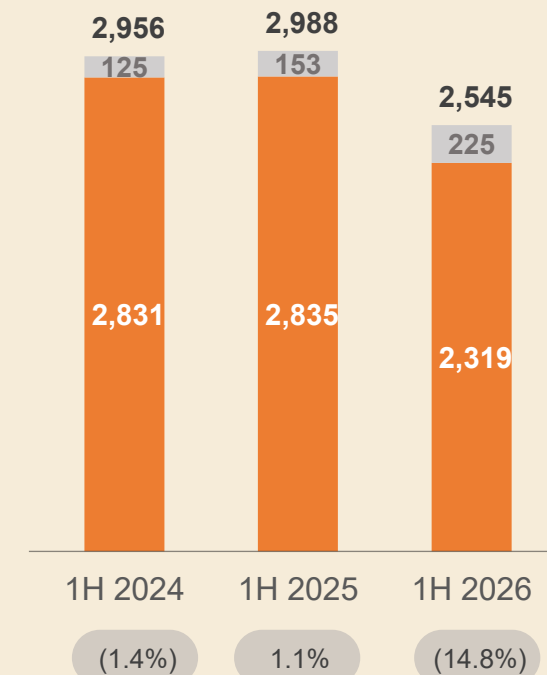

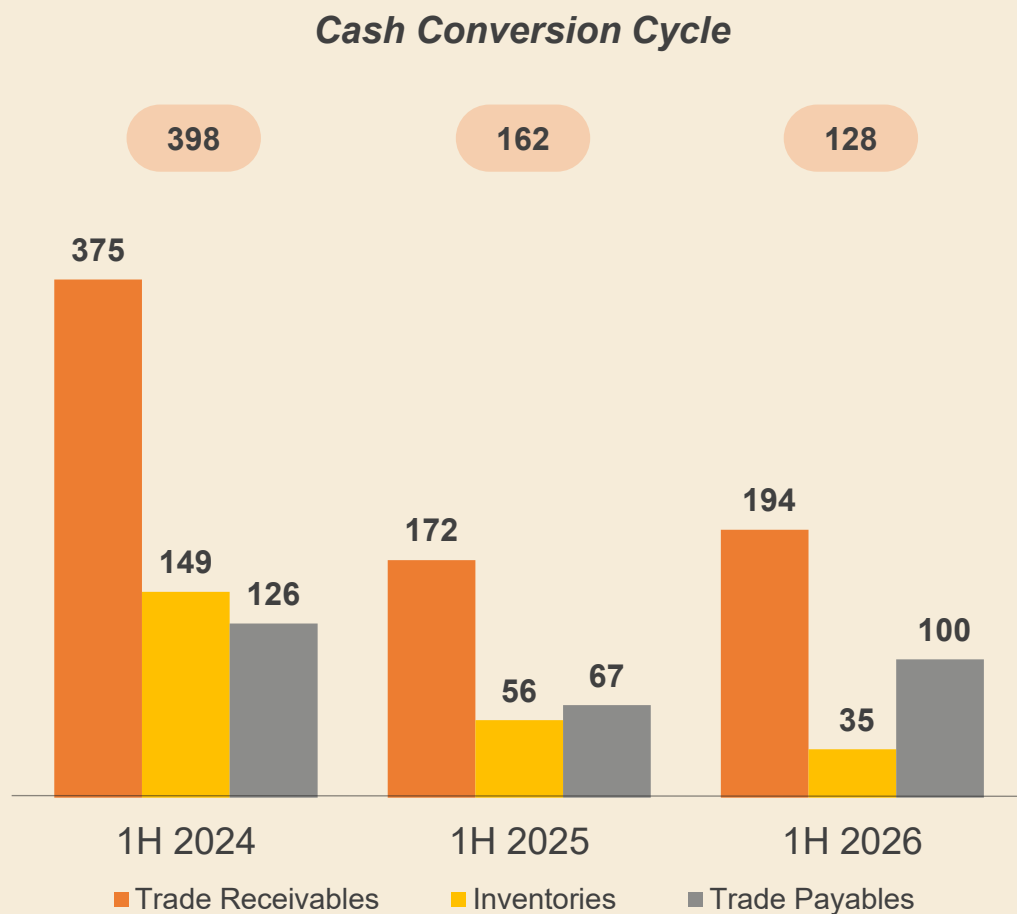

Turnover Days – Average Method ⁽¹⁾

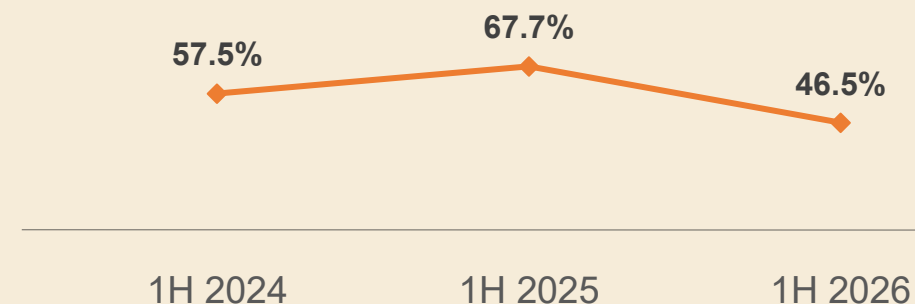

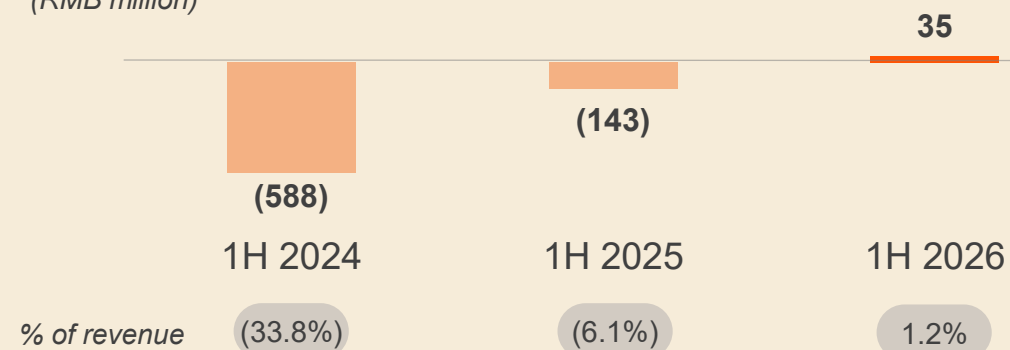
Provision for Impairment as % of Gross Trade Receivables (Balance Sheet)

Net Impairment Losses (Income Statement)

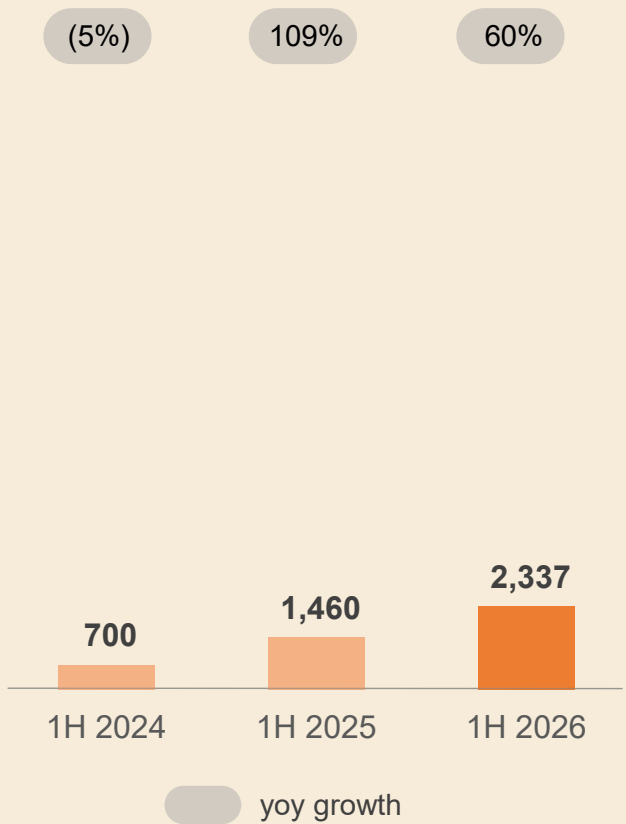

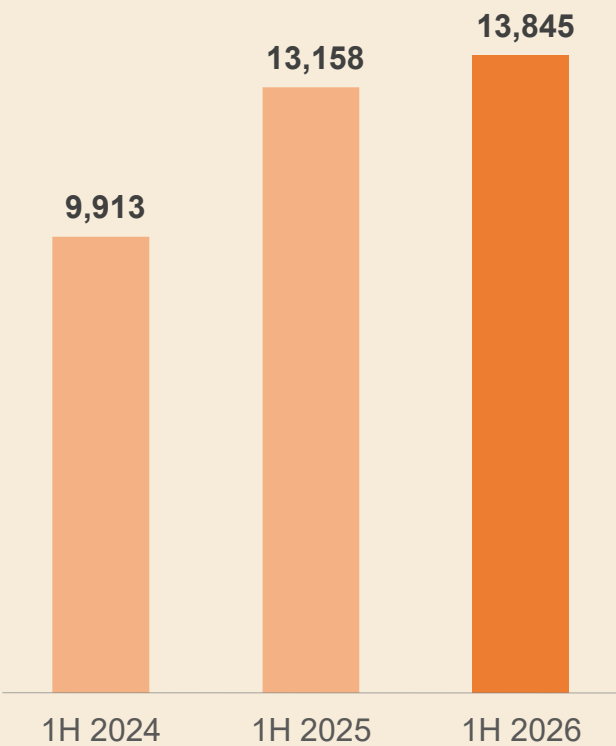

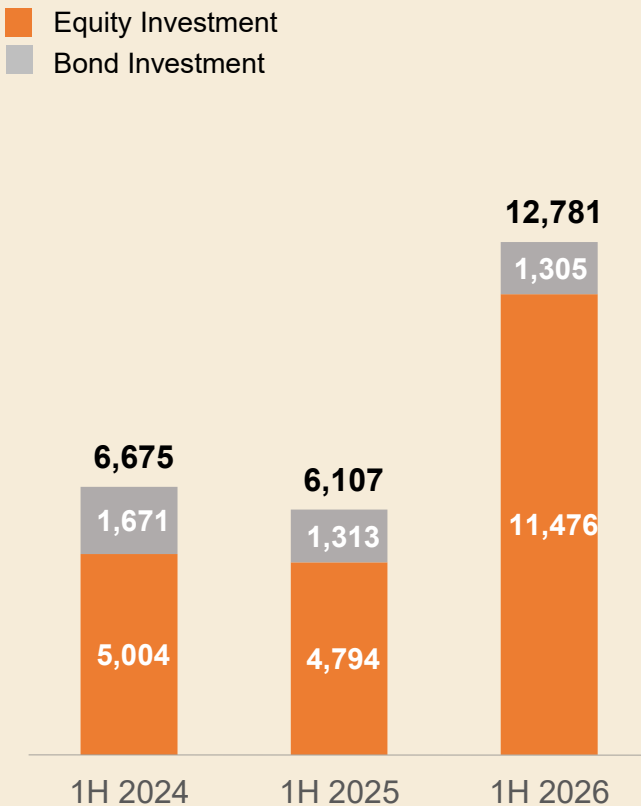
